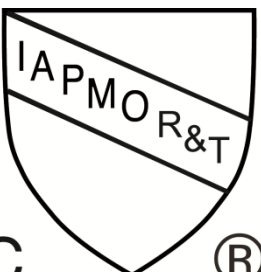

ISO/IEC 17067, Conformity assessment - Fundamentals of product certification and guidelines for product certification schemes, *scheme type 5* most closely resembles the product certification scheme operated by this organization. The surveillance part of this scheme allows for the choice between periodically taking samples of the product either from the point of production, or from the market, or from both, and subjecting them to determination activities to



check that items produced subsequent to the initial attestation fulfil the specified requirements.
