IAPMO R&T Provides ENERGY STAR® Certification for Tankless Water Heaters

Manufacturer Noritz received ENERGY STAR® certification for four models and Grand Hall for two models.

Noritz's propane and natural gas water heaters — NR50-OD (Natural Gas), NR50-OD (Propane), NRC98-DV (Natural Gas), NRC98-DV (Propane) — are now ENERGY STAR® certified to deliver around a 30 percent reduction in energy use over traditional tank water heaters while also reducing the levels of CO2 emitted into the atmosphere by at least 700 lbs. per year.
