Prior to his work with PMI, Viola worked on the *International Plumbing Code* with BOCA International and the International Code Council. His responsibilities with these organizations included serving as secretary of the plumbing code, evaluating plumbing products for code compliance, and developing and conducting seminars.

Thanks to an early start in the family plumbing business, Viola's knowledge of the plumbing industry comes from practical, hands-on experience. He built upon this foundation with a mechanical engineering degree from Northern Illinois University.
