#### Report on Comments Toward Development of 2024 UPC, UMC Now Available for Online Download

**Ontario, Calif. (Aug. 12, 2022)** — The International Association of Plumbing and Mechanical Officials (IAPMO), developer of the *Uniform Plumbing Code (UPC®)* and *Uniform Mechanical Code (UMC®)*, has posted online the 2022 *Report on Comments (ROC)* for the 2024 editions of these American National Standard-designated model codes. The *ROC* includes the committee action as discussed during the May 2-5 technical committee meeting, the electronic ballot results as balloted between May 16 and June 10, and the Technical Correlating Committee action on all comments received for the 2024 editions.
