IAPMO Assists Updating of OMB Circular; Uniform Codes Exceed Requirements in Revised Version

IAPMO® is proud to have submitted comments, participated in public hearings, and worked with the U.S. Office of Management and Budget (OMB) throughout the process of updating Circular A-119: Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities. Not all code and standard bodies adhere to the strict open consensus process, but as an ANSI Audited Designator IAPMO's *Uniform Codes* exceed the consensus and balance requirements set by OMB throughout the entire code development process — from inception to final vote.

The policies of Circular A-119 are intended to encourage federal agencies to benefit from the expertise of the private sector, promote federal agency participation in standards bodies to support the creation of standards that are useable by federal agencies, and minimize reliance on government-unique standards where an existing standard would meet the federal government's objective. Circular A-119 was issued in 1993 and last revised in 1998.

Many voluntary consensus standards are appropriate or adaptable for the government's purposes. The use of such standards, whenever practicable and appropriate, is intended to achieve the following goals:

- a. Eliminate the cost to the government of developing its own standards and decrease

the cost of goods procured and the burden of complying with agency regulation.

b. Provide incentives and opportunities to establish standards that serve national needs.

c. Encourage long-term growth for U.S. enterprises and promote efficiency and economic competition through harmonization of standards.

d. Further the policy of reliance upon the private sector to supply government needs for goods and services.

IAPMO and other industry partners recommended that OMB expand the Circular's requirements for openness, balance, due process, and an independent appeals process. In the previous Circular, these terms had neither an explanation nor definition.

"These revisions are a victory for all who follow and adhere to the American National Standards Institute (ANSI) process, particularly those who have obtained the ANSI Audited Designator Status," said Dain Hansen, Senior Vice President of Government Relations at The IAPMO Group. "The biggest beneficiary, however, is the American people, who will be further protected from substandard products and processes infiltrating the federal government as it works to promote the general welfare."

EPA Releases Update on Flint, MI. Response Activities

EPA teams are collecting drinking water samples from Flint homeowners to better understand how lead is behaving in the plumbing in their homes and to ensure proper corrosion control is being restored in the drinking water system in order to lower lead levels. EPA community involvement and sampling teams continue to meet with residents to explain the sampling process and answer questions.

Samples will be sent to an EPA laboratory for analysis. The quality assured results of the samples collected by EPA will be shared with individual homeowners and the results will be posted on EPA's website. EPA will also ensure removal of any personal information from the results and will post the data as soon as it becomes available.

Last week, EPA issued a Safe Drinking Water Act Emergency Order to ensure the state

and city immediately take actions necessary to protect public health. The Safe Drinking Water Act Emergency Order requires the state of Michigan and city of Flint to take a series of immediate steps to address the drinking water contamination in Flint.

EPA recommends that residents continue to use filters or drink bottled water. EPA also recommends that residents, if they have concerns, contact their local health provider to have themselves or their children tested for lead. EPA will continue to work with the city of Flint to monitor drinking water quality and to ensure the public is receiving up to date information.

New Construction Starts in December Improve 4 Percent; Annual Total for 2015 Climbs 8 Percent to \$645.5 Billion

New construction starts in December advanced 4% to a seasonally adjusted annual rate of \$591.6 billion, according to Dodge Data & Analytics. The December gain follows a 5% decline in November, and brings total construction activity back close to the amount that was reported in October. December showed moderate increases for each of the three main construction sectors – nonresidential building, residential building, and nonbuilding construction (public works and electric utilities). For 2015 as a whole, total construction starts climbed 8% to \$645.5 billion. This continues the pattern of moderate expansion for total construction starts registered during the previous three years – 2012, up 12%; 2013, up 11%; and 2014, up 9%.

The December statistics produced a reading of 125 for the Dodge Index (2000=100), compared to a revised 120 for November. For all of 2015, the Dodge Index averaged 137. "The construction start statistics reveal continued expansion for construction activity during 2015, although the path over the course of the year was not smooth," stated Robert A. Murray, chief economist for Dodge Data & Analytics. "A strong first half of 2015 was followed by a 20% loss of momentum in the third quarter and then a slight 1% rebound in the fourth quarter, as the expansion began to show that it was getting back on track. Several factors contributed to the early 2015 strength – more growth for the commercial and institutional segments of nonresidential building, gradual improvement for single family housing alongside the continued rise by multifamily housing, and a surge of electric utility and gas plant projects that featured the start of several massive liquefied natural gas (LNG) terminals in the Gulf Coast region."

"The third quarter of 2015 witnessed a steep 30% drop for nonresidential building, as the manufacturing building category and in particular energy-related projects fell sharply," Murray continued. "In addition, the commercial and institutional building segments of nonresidential building settled back, as earlier gains may have overshot their underlying growth trend while uncertainty in the economic and political environment dampened investment in general. Residential building slipped 3% in the third quarter, due to flattening activity for single family housing, while nonbuilding construction plunged 32% as the result of a sharp reduction by the electric utility and gas plant category. On the plus side, the fourth quarter of 2015 showed the commercial and institutional segments of nonresidential building beginning to pick up the pace once again, and supportive market fundamentals (occupancies and rents) should help renewed growth for these segments going into 2016. The public works portion of nonbuilding construction also began to pick up the pace towards the end of 2015, and should be aided by the December passage of fiscal 2016 federal appropriations as well as the new \$305 billion five-year federal transportation act (the Fixing America's

Michigan Hotel Evacuated After Guest Contracts Deadly Bacteria

Officials from Lac Vieux Desert Resort Casino in upstate Michigan say the Legionella bacterium, which causes Legionnaire's disease, has been found in the resort's hotel. After one guest contracted the illness, they evacuated the building. Water samples from the hotel tested positive for the bacteria. Officials say they have already begun sanitizing, and will not re-open until they are confident it's safe. Legionnaire's disease is a water-borne bacterium that transmits through mist. It's most commonly found in buildings with complex water systems, like hotels. It can't spread person-to-person. The outbreak could have serious economic repercussions for this small community. The closure could mean big losses for the resort as winter tourism brings in much of their business.




